Words from the IFCS President

During the past few months, the local organizers of the forthcoming IFCS-2013 meeting in Tilburg (The Netherlands) have been working diligently on the preparation of the conference, in consultation with the IFCS-2013 Scientific Program Committee and the IFCS Executive Committee. These efforts have been very successful, leading to the foundations of a most impressive conference program, with seven distinguished invited speakers, eleven thematic invited sessions (that cover a broad range of IFCS-related topics), and four interesting pre-conference tutorials. More information on all of this, as well as many practical details, can be found on the conference website: www.ifcs2013.org. In this Newsletter you will find a second call for papers, with an invitation to submit both individual papers and proposals for thematic sessions. Let me warmly encourage all of you to respond to this call at your earliest convenience!

As mentioned in the previous Newsletter, at the occasion of IFCS-2013, the Federation will again

award a small number of Chikio Hayashi prizes to (relatively) young, promising researchers on the basis of a solid scientific track record and impact on classification research. For researchers in earlier stages of their scientific career, it is typically quite a challenge to fill out the honors and awards section of their CV. I trust that a Chikio Hayashi Award will imply a significant support at this point, especially so if one takes into account that the 2013 Chikio Hayashi Awards committee comprises once again a group of very distinguished scholars. Elsewhere in this Newsletter you will find more information on the application procedure, and the application form can be downloaded from the IFCS2013 website. Let me strongly encourage once again all promising, young researchers in the areas of classification and data analysis to submit an application!

As also mentioned in the previous Newsletter, the IFCS has launched a benchmarking task force. This will help to address the problem that, nowadays, new methods, algorithms, and data-analytic devices are very often proposed within the classification domain without adequate comparison with current best practices or gold standards, and without sufficient evidence of performance on benchmark data sets. Since the appearance of the previous Newsletter, this task force has had an intensive two-day meeting, during which significant progress has been made on several initiatives to support and promote benchmarking within the classification domain. More details on this will be communicated within the next few months. Moreover, in addition to an IFCS invited session on benchmarking (scientifically sponsored by both IFCS and IASC) at the World Statistics Conference (ISI) in Hong Kong (August 2013), several members of the task force will also contribute to a plenary Presidential invited session on benchmarking at the forthcoming IFCS-2013 conference in Tilburg.

One of the other challenges IFCS wants to address in the coming year is establishing more effective communication with the IFCS member societies and their individual members. Key elements at this point include an upgrade of the IFCS website (which will have a new URL, owned by the federation, www.ifcs.info). This upgrade will imply a more flexible and regular updating of information, and the addition of a calendar with up-to-date information on

conferences and other scientific activities that may be relevant for significant parts of the IFCS community. Moreover, the IFCS website will also be given a pivotal role in the distribution of information resulting from the IFCS task force on benchmarking, including a broad repository of benchmarking data sets. All these changes will go with a migration of the IFCS website to the University of Natural Resources and Life Sciences (BOKU) in Vienna, Austria. This migration implies the closing of a very lengthy period in which David Dubin served as IFCS webmaster. At this occasion, I would like to take the opportunity to warmly thank Dave for the invaluable efforts he has paid to the federation during so many years. I would also like to thank Friedrich Leisch and his co-workers at BOKU for their hospitality and their invaluable help in the setting up of the new website. And of course, many thanks also go to IFCS Publications Officer Paul McNicholas for all his efforts on this project.

A second element in the establishment of a more effective communication will be the publication of three (rather than two) issues per year of the Newsletter. We hope that this will allow us to be right on the ball for spreading more urgent information (including various calls, and announcements of scientific meetings). Moreover, the publication of this additional issue will also go with the introduction of a new book reviews section. More information on this and on the deadlines for submitting contributions for the different issues of the Newsletter can be found further on in the present issue. Enjoy the reading!

News from the IFCS Scientific Secretary

During the past year, several proposals were put to an electronic Council vote. Below, you may find information on these proposals and on the voting results (items 1–4), together with the composition of the Chikio Hayashi Awards Committee for the next IFCS conference, IFCS-2013 (item 5).

1. Vote on a proposal of the IFCS Executive Committee on the financial involvement of the

federation in IFCS conferences (December, 2011 – January, 2012)

During the Frankfurt meeting, several IFCS Council members informally suggested revising the rules for the financial involvement of the federation in IFCS conferences. These suggestions were motivated because of the risk the organization of an IFCS conference implies for the organizing IFCS member society, especially in view of the global financial crisis.

The IFCS Conference Guidelines had been based on the principle of an equilibrium: On the one hand, the federation did not bear any conference risks, but on the other hand, the federation did not claim any share in a possible conference profit. Up to now, the financial involvement of the federation has further been limited to the possibility of a loan (up to USD 10,000), to be paid back within six months after the conference.

The IFCS Council approved a proposal of the IFCS Executive Committee to modify the financial involvement of the federation in the organization of IFCS conferences as follows: The federation may share the financial risk of the conference organization with the conference organizers, 50% for the federation and 50% for the organizers, up to a maximum of USD 10,000 for the federation; the federation will then also share the possible profit of the conference organization with the conference organizers, with the same distribution as for the risk, 50% for federation and 50% for the organizers, and with the same maximum amount of USD 10,000 for the federation. The IFCS Council finally approved the greater financial involvement of the federation be accompanied by a somewhat greater involvement in the conference organization.

2. Vote on the bid from Tilburg/VOC to host the conference IFCS-2013 (March 2012)

The IFCS Council has approved the Tilburg/VOC bid for the organization of IFCS-2013.

3. Election of a new member of the Finance Committee (August - September 2012)

As the term of Stanley L. Sclove (CS) on the IFCS Finance Committee recently expired, one position of member on this Committee had to be filled. Daniel Baier (GfKI; Brandenburgische Technische Universität, Cottbus, Germany) was nominated for this position by the IFCS Executive Committee, and he accepted this

nomination. This nomination was subsequently approved by a formal Council vote.
